- (f) To establish maintain or grant in aid to homes for the aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and aged persons.
- (g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- (h) To grant relief and assistance to the needy victims during natural calamities such as famine, earthquakes, flood, fire pestilence etc. and to give donations and other assistance to institutions establishments or persons engaged in such relief work.
- (i) To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise, to different charitable institutions, societies, organizations or Trusts in India which may have been established or which may hereafter be established for the like charitable purposes mentioned in these presents or any of them, to enable such institution, societies, organizations or Trustees to start maintain or carry-out such charitable objects.

- r) To transfer and hand over the Trust to any other society, Corporation, Institution, Trust or Organization on such terms and conditions as the Trustees shall in their absolute discretion think fit and proper to be held by the said society, Corporation, Institution, Trust or Organization with the powers, provisions, agreements and declarations, appearing and contained in these presents and the Trustees herein shall stand discharged from the Trust hereof relating to Trust properties and Funds so transferred.
- s) To promote, establish, support, maintain, grant in aid to institutions for the promotion of science literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institution in India having similar objects for the benefit of the public in general.
5. That the Trust fund may be augmented by the Income from the initial fund and also by donations or other contributions from time to time.
6. That the Trustees shall maintain proper books of accounts of the Trust which shall be kept at the office of the Trust. The accounts of the Trust shall be maintained regularly and the accounts shall be audited by a duly qualified Chartered Accountant every year.
7. That the Trust Fund shall be applied for purposes specified in para 4 hereinabove and any other purposes which the Trustees may determine from time to time which any how shall be for public charitable purposes. No portion of the Trust Fund and Trust income shall be utilized for payment to Trustees by way of profits, interest, dividends etc., Other things being equal the trustees may give preference to Catholics in giving benefits from the Trust funds.

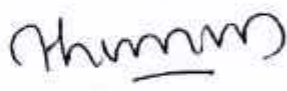
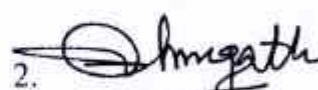
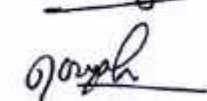
8. That in furtherance of the objects of the Trust, the trustees shall have the following powers:

- a) To accept donations, contributions, grants, subscriptions in cash or in kind, from any person(s) body of persons or trust, with or without conditions, towards corpus of the Trust or otherwise.
- b) To apply the whole or any part of the income of the Trust, or Trust fund or accumulations, thereof on one or more objects of the Trust as the Trustees may deem fit from time to time.
- c) To invest the trust funds in such of those securities, properties both movable and immovable, banks Post Office or Government Securities and to alter, vary or dispose off such investments from time to time at the discretion of the Trustees. However such investments of Trust Funds shall be governed by the provisions of the Income Tax 1961.
- d) To open accounts in the name of the Trust, Trustees, and or Institutions, run conducted by the trust with a bank or banks, to operate such accounts and to give instructions to the bank and to provide for opening and operation of the accounts by one or more of the Trustees or an agent appointed by the Trustees.
- e) To make vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- f) To start, establish, discontinue and restart any charity or charitable institutions for the benefit of general public.
- g) To set apart and or allocate the whole or a part of the income or the corpus of the Trust Fund or part thereof for any of the objects of the Trust.

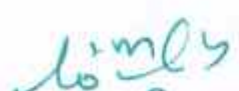

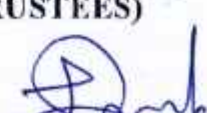

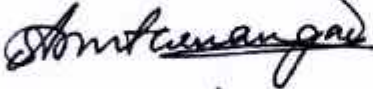

- h) To join, co-operate or amalgamate this Trust with other or others having similar or allied objects upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
9. The trustees shall be accountable only for such moneys, stocks, shares and funds as shall actually come into their hands and a Trustee shall not be answerable or accountable for neglect, default, acts or omission of the other Trustees nor of any banker or other person with whom the Trust properties or any securities may have been deposited or kept.
10. The trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.
11. The number of the Trustees shall not be less than two and not more than Fifteen.
12. That 1. **Rev.Fr.Antony Puthenangady .P.V.** and 2. **Rev.Fr. Philips.P.R.** shall be Life Time Trustees and shall hold office till their life time or till they voluntarily retire.
13. That one third Trustee of the Trustees other than the Life Time Trustees shall retire by rotations once in Two years and are eligible for re-election.
14. Every Trustee will be at liberty to resign on giving one month's notice of his/her intentions to do so and the resignation shall become effective upon acceptance in a Meeting of the Trustees.
15. The trustees may from time to time frame rules for the conduct and regulations of the meetings of the Trustees. In the absence of such regulations:

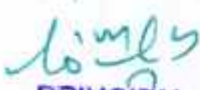
- a) One third of the total number of Trustees present for the time being within half an hour from the scheduled time to commence the Meeting, shall form a quorum for a meeting of the Trustees.
 - b) All matters will be mutually decided by a simple majority of the Trustees.
 - c) Any Resolution passed without any meeting of the Trustees but by circulation thereof in writing under the hands of atleast fifty percent of the Trustees in concurrence with the life time Trustees shall be as valid and effectual as a Resolution duly passed at a meeting of the Trustees.
16. The trustees shall have powers to pursue objects not expressly stated in this declaration but which are public charitable in nature, by resolutions passed at their meetings, which are not repugnant to the provisions of the Income Tax Act.
17. The trustees shall have the power to determine in case of doubt whether any moneys or property received shall be considered as capital or income and whether out of income or capital any expenses or out going ought to be paid or borne out of income or capital and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the trustee to spend the income or the corpus of the Trust for any purpose not authorized by these presents.
18. The accounting year of the Trust shall be the financial year ending on 31st March every year.
19. The trust is irrevocable for all times.
20. The office of the Trust shall be situated in Tamil Nadu unless changed by the Trustees through a resolution in a meeting of the Trustees.

In the absence of both of them, the other Trustees can elect any one amongst themselves to act as the Managing Trustee till the return of one of the Managing Trustees to Head quarters.
22. For removal of doubts it is hereby declared that this Trust, its objects and its implementation shall not be for the benefit of any particular caste or community or religions group as such.
23. It is expressly declared that no part of the Trust property or its income or any accretion thereto shall be applied for any purpose outside India or for any purpose which is not a charitable purpose in law, and all provisions here of shall be construed accordingly.
24. Amendments to the Trust Deed and other Supplemental deeds which may be executed from time to time to form part of the original declaration, shall be carried out only with the approval of the Commissioner of Income Tax, having Jurisdiction for purposes of the Income Tax Act.
25. The income of the Trust shall be solely utilized towards the objects of the Trust and no portion of it shall be utilized for payment to the Trustees or their relatives by way of profits, interest, dividend etc.
26. In the event of the Trust being dissolved on account of its failure to carry on the objects as provided in this declaration of trust or otherwise, the net assets available on dissolution shall be donated to any other Trust having similar objectives of our trust which are public charitable in nature.
27. There is no movable or immovable property of the Trust at present except **Rs.1,000/- (Rupees One Thousand only)** mentioned here in above.
